- Restricted Stock Unit ("RSU") award granted awarded to Ms. Baty as an inducement award outside of the Freshpet, Inc. 2014 Omnibus Incentive Plan in accordance with NASDAQ Listing Rule 5635(c)(4). This Buy-Out Inducement Award will vest at 39%, 48% and 13% on the first, second and third anniversary of the grant date, respectively, in each case subject to Ms. Baty's continued service with the Company.
- RSU award granted awarded to Ms. Baty as an inducement award outside of the Freshpet, Inc. 2014 Omnibus Incentive Plan in accordance with NASDAQ Listing Rule 5635(c)(4). This Special Inducement Award is comprised of (i) 3,860 RSUs which vest in three equal installments on the first, second and third anniversary of the grant date, and (ii) 1,930 RSUs which vest at 100% on the third anniversary of the grant date, in each case subject to Ms. Baty's continued service with the Company.
